2025 PERSONAL INCOME TAX REMINDER

It is that time of year again. It may take a couple months for all your income tax slips to reach you. Once you've gathered your tax information, simply drop it off at our office or upload it to our secure client portal.

- Please wait until you have all your tax documents before dropping them off
- There is **no need to schedule an appointment to drop off** tax documents, the office is open Mon to Fri, 9 am to 5 pm
- We aim for a two-week turnaround from receipt of all your tax documents
- We will contact you when the return is completed to schedule a meeting to review and sign off your return before efilng
- If you are going to be away in the last two weeks of April, please let us know at drop off
- If you receive late or amended tax slips, provide them to us as soon as possible to avoid CRA assessing penalties

- For existing clients, use your "Federal Slips Summary" in your 2024 tax package as a checklist for expected tax slips

TAX SLIPS – When to expect your tax slips to arrive?

Most tax slips are required to be issued by February 28. However, T3 and T5013 slips do not have to be issued until **March 31** so these may not arrive until April. A reminder to **watch for notifications from your online bank or investments** accounts for tax documents they send you electronically, as **you will need to print these off** and include them with your records.

- Details of **specified foreign property** including digital currency, shares of US or other foreign countries held in a non-registered Canadian investment account with a total cost of more than \$100,000 CAD at any time during the year
- Did you receive interest, dividends, or benefits from a private corporation or trust which **you inherited** or in which a **relative is a key party** (in terms of ownership or involvement) which are not exempt from TOSI (tax on split income)?
- Did you receive distributions or loan money to a foreign trust?
